

Privacy Policy

to General Terms and conditions of FITEQ – Teqball Creative Concept / Tender Process

This Privacy Policy (**Privacy Policy**) provides you with the information regarding the processing of your personal data carried out by **FÉDÉRATION INTERNATIONALE DE TEQBALL** (a non-profit company incorporated under the laws of Switzerland and having its registered office at chemin de Beau-Rivage 7, c/o Ametis Conseils SA, 1006 Lausanne, Switzerland, registered under registration Nr.: CHE-327.306.301; the FITEQ; **Controller, We or Us**) in relation to your participation at the Teqball Creative Concept Tender Process.

Definitions used in this Policy

In this section you can find the definitions for the purpose of this Privacy Policy.

Data Processing: means any operation or set of operations which is performed on Personal Data or on sets of Personal Data, whether or not by automated means, such as collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction;

Data Processor: means a natural or legal person, public authority, agency or other body which processes Personal Data on behalf of Us.

Personal Data: means any information relating to you through which We can identify you directly or indirectly; it means in particular your name, identification number, bank account number, contact details or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of yours;

Prize: means the prize money of EUR 25,000 offered to the winning bidder in return for the exclusive ownership of the concept submitted in the Tender and/or the prize money of EUR 5,000 to shortlisted but ultimately unsuccessful bidders in return for the exclusive ownership of their concept.

Tender: means the FITEQ – Teqball Creative Concept / Tender Process.

Tender Documentation: means the invitation to express interest and the General terms and conditions of FITEQ – Teqball Creative Concept / Tender Process

You: means a natural person or a natural person representative/contact person of a company or other organisation who submits a concept including a plan of an event of Teqball competition types and a media concept for Teqball (the Concept) as set forth in the Tender Documentation.

I. Principles of the Data Processing

We are processing your Personal Data in compliance with all the relevant laws, fairly and in good faith.

We are processing your Personal Data only for specified and legitimate purposes proportionally as described in this Privacy Policy.

We are processing your Personal Data in a manner that ensures appropriate security, including protection against unauthorized or unlawful processing and against accidental loss, destruction or damage.

II. Relevant circumstances of the Processing (purpose, legal basis, processing period etc.)

We are processing your Personal Data in relation to your participation in the Tender. The purpose of data processing is to be able to evaluate the bids received in the Tender, to notify you on any relevant information relating to the Tender e.g. the result of the Tender and to perform the contract to be potentially concluded with You in case you are announced as a winning or shortlisted bidder as described in the Tender Documentation.

The legal basis for processing your Personal Data is your unequivocal consent given based on proper information. By confirming your interest to us by e-mail you agree to the processing of your personal data as described in this Privacy Policy.

If You are not chosen as a shortlisted or winning bidder, we will only process your Personal Data until the Winning Bid is selected.

If You are selected as a shortlisted candidate we will process your Personal Data as long as it is necessary for the payment of the Prize as applicable or as long as it is legally required from Us by the relevant laws.

If You are selected as winner we will process your Personal Data as long as it is necessary for the payment of the Prize, for the realization of the project or otherwise required by the relevant laws.

Please be aware, that you have the right to revoke your consent at any time, even before the above mentioned periods lapse. In this case we will process your Personal Data only until the revocation of the consent. Please be aware however, that in this case we will not be able to fulfill our obligations under the Tender Documentation (e.g. we may not consider your concept as a shortlisted or winning bid).

Please note that in the event of any inquiries coming from state, administrative or investigative authorities We are obliged to provide these authorities with your Personal Data if they request Us to do so.

We also note that We are not carrying out any automated decision-making or profiling activity in relation to Data Processing.

III. Personal Data processed by Us

In order to express interest and participate in the Tender, You shall provide Us with your name, your e-mail address, your telephone number, and other contact information.

In case you are chosen as a shortlisted or winning bidder, and you are a natural person, we will also process the data listed below:

- your bank account number
- Your tax identification number

Personal Data processed in relation to the concept submitted in the Tender

In case your concept or plan submitted in the Tender includes any other personal data that is not listed in the above points, We will process such data only to the extent and only as long as it is necessary for the purposes described in this Privacy Policy.

IV. Data Processors

Please note that We are using Data Processors for support services in relation to the Tender and these Data Processors receive Your Personal Data for the purpose of providing Us with such services. The table below indicates all Data Processors who receive Your Personal Data.

V. Your rights regarding the Data Processing carried out by Us

You have the following rights regarding Data Processing carried out by Us in relation to Your Personal Data:

- *right to access*

You have the right to request from Us access to Your Personal Data processed by Us and obtain the information regarding what is the purpose of the processing, what categories of Personal Data are processed, for or towards who are We transferring or disclosing Your Personal Data, for what period are We processing Your Personal Data, Your rights in connection with Data Processing carried out by Us regarding Your Personal Data, Your right to lodge a complaint with a supervisory authority regarding the processing, in case We collect Your Personal Data from other sources than You, any available information as to the source, and the existence of automated decision-making and related information including the logic involved, as well as the significance and the envisaged consequences of such processing for You.

We provide You with a copy of your personal Data processed by Us in case You require Us to do so.

- *right to rectification*

You have the right to request Us to rectify your inaccurate Personal Data and to request Us to complete your incomplete Personal Data by means of providing Us with a supplementary statement.

- *right to erasure*

We erase any of your Personal Data without delay if You request Us to do so in the event of the followings:

- Your Personal Data is no longer necessary for the concerning purpose;
- You withdraw Your consent and there is no other legal basis for the processing;
- You object to the processing and there are no overriding legitimate grounds for the processing;
- Your Personal Data have been processed unlawfully;
- Your Personal Data have to be erased according to relevant laws.

Please note that We are entitled to not erase Your Personal Data if it is necessary - among others - for exercising of right of freedom of expression and information, compliance with legal obligation, establishment, exercise or defense legal claims.

- *right to restriction of processing*

You have the right to obtain from Us restriction of processing where one of the following applies:

- a) You have contested the accuracy of your Personal Data, for a period enabling Us to verify the accuracy of your Personal Data;
- b) the processing is unlawful and You oppose the erasure of your Personal Data and request the restriction of their use instead;
- c) We need no longer your Personal Data for the purposes of the processing, but they are required by You for the establishment, exercise or defense of legal claims.

- *right to object to processing*

Where Personal Data are processed for direct marketing purposes, You have the right to object at any time to processing of Personal Data concerning You for such marketing, which includes profiling to the extent that it is related to such direct marketing.

- *right to withdraw your consent*

You have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on your consent before its withdrawal.

We take actions requested in relation to exercising your above rights without undue delay and in any event within one month of receipt of your request. Align with a reasoned notification to You, this period may be extended by two months where necessary, taking into account the complexity and number of requests.

In the event of You make such a request by electronic means, We provide You with information by electronic means where possible, unless You request otherwise.

In case We do not take any action regarding Your request, We inform You as to the reasons within one month of receipt of Your request. We take the necessary actions regarding exercising your rights in relation to the processing free of charge except if Your request is manifestly unfounded or excessive.

In case We have reasonable doubts as to the identity of the natural person making the request, We may request the provision of additional information necessary to confirm the identity of such person.
